The Kindersley Fire Dept. will do it's very best to accommodate the requested date(s) but cannot guarantee them. Unless other arrangements were previously made, the trailer will be available for pick-up the night before the scheduled events and expected to arrive back in Kindersley the morning after the scheduled events.

The trailer weighs 5,500lbw, it is approximately 18' long and 7'wide on a single axle. It is towable by most trucks and large SUVs. Kindersley Fire Dept requires that the trailer be pulled by commercially plated or fire service vehicles.

The person/event applying for use of the trailer will be financially responsible for any damage occurred during the event. This includes but is not limited to; lost or stolen items, damage caused by wind or rain, mud and dirt damage, vandalism, or misuse. It is expected that the trailer will leave your event in the same condition that we brought it to you. Any issues must be noted immediately, or it will be assumed that they were caused during your event. It is important to take care when using the dunk tank to prevent holes and ensure it is dried before putting it away. The Keizer sleds require a clean and lubricated surface; the dead blows must be hit flat on the head or there is risk of damaging the hammer. It is the responsibility of the organizing event team to ensure that the items are maintained and used correctly while in their possession.

The event team understands that they need to donate to the trailer's operations and maintenance fund. \$250.00 for a 1 or 2-day event, or \$350 for 5 days. These funds can be e-transferred firepubed@kindersley.ca or a cheque made out to Kindersley Fire Brigade. We will provide a letter of appreciation for your donations to the public education trailer. Under the scope of the donation, the borrower will move the trailer to and from their event.



Cancellation and Refunds

If your team needs to cancel the Public Education Event Trailer, you'll be refunded 100% up to 48 hours before event. 48 hours or less you'll be refunded 60% of fees. If for any reason Kindersley Fire Dept. needs to cancel the trailer, you will be refunded 100%. Your booking of the trailer will not be finalized until you have sent the full donation amount., and necessary paperwork

OBLIGATIONS

- As an event you will be obligated to post a minimum of 2 photos on social media.
- There must be at least one photo of each side of the trailer posted.
- At no time can any of our sponsors' names be blocked or covered.
- Kindersley Fire must also be tagged in the social media posts, and we have full rights to share or use the photos as we see fit.
- The event must provide free access to our team to their event, the includes any of our support groups such as tow companies.
- Silver Collection donations and/or merchandise for sale may not be impeded or blocked by the Event.
- You may not charge entrance fees to see the trailer.

Protective Services – Public Education Trailer Use Agreement

This Agreement is made between **Kindersley Fire Department – Protective Services** (hereafter referred to as the “Department”) and the undersigned individual or organization (hereafter referred to as the “User”).

1. Purpose

The Department agrees to allow the User to utilize the **Kindersley Fire Department Public Education Trailer and associated training equipment** for approved fire safety education or training purposes.

2. Equipment Value

The Public Education Trailer and associated equipment have an estimated replacement value exceeding **\$12,000**. The User acknowledges this value and agrees to exercise reasonable care in its use, operation, and supervision while in their possession.

3. Damage Deposit

A **refundable damage deposit of \$1,000.00** is required prior to the release of the trailer.

The deposit will be returned following inspection of the trailer and equipment by the Department, provided no damage, misuse, or loss has occurred.

4. Damage or Loss

The User agrees to be responsible for any damage, theft, or loss of the trailer or equipment while it is in their possession.

If damage occurs:

- The Department may retain part or all of the deposit to cover repair costs.
 - If repair or replacement costs exceed the deposit amount, the User agrees to reimburse the Department for the remaining costs.

5. Inspection

A **pre-use inspection** and **post-use inspection** will be conducted by the Kindersley Fire Department. And if explicable with the person picking it up.

Any damage, missing equipment, or operational concerns will be documented during the post-use inspection.

6. Proper Use

The User agrees that:

- The trailer will only be used for **fire safety education or training purposes**.
 - No equipment will be removed, altered, or modified.
 - The trailer will be operated safely and responsibly at all times.

7. Weather Protection

The User agrees that the trailer and its equipment will be protected from **extreme weather conditions**, including heavy rain, hail, high winds, or snow.

The trailer must not be used in conditions that could damage the structure, electrical systems, or training equipment.

8. Transportation Responsibility

If the User is responsible for transporting the trailer, the User agrees that:

- The towing vehicle must be properly equipped and rated for safe towing.
 - The trailer will be transported in accordance with provincial traffic laws.
 - The User assumes responsibility for any damage resulting from transportation, towing accidents, or improper handling.

9. Supervision of Participants

The Kindersley Public Education Trailer is intended for **controlled training**

environments. The User agrees that:

- Children and participants must be **supervised at all times**.
 - No participant may use the trailer without adult supervision.
 - The User assumes responsibility for maintaining a safe environment during its use.

10. Insurance

The User agrees to maintain appropriate **general liability insurance coverage** for the duration of the trailer use.

The User acknowledges that they are responsible for any damages, injuries, or losses occurring while the trailer is in their possession or under their supervision.

Where applicable, the User may be required to provide proof of insurance naming the **Kindersley Fire Department and the Town of Kindersley as additional insured parties** prior to the release of the trailer.

11. Liability

The User agrees to **indemnify and hold harmless the Kindersley Fire Department, the Town of Kindersley, and their officers, members, and representatives** from any claims, damages, injuries, or liabilities arising from the use of the trailer.

12. Return Condition

The trailer must be returned:

- In the same condition as received
 - Clean and free of damage
 - With all equipment present and secured
